THE WINNING HORSE WILL AUTOMATICALLY BE GIVEN AN ENTRANCE INTO THE PREAKNESS STAKES AT PIMLICO. THE HORSE MUST BE NOMINATED TO THE TRIPLE CROWN TO BE ELIGIBLE. Weight: 122 lbs.
