THE FOLLOW-UP EXAM MUST OCCUR NO LATER THAN 45 DAYS AFTER THE INITIAL EXAM, OR ALL TRAINING MUST CEASE UNTIL AFTER THE FXAM IS PERFORMED. THE EXAM IS PERFORMED.
