ATTENTION HORSEMEN: 4-YEAR-OLD'S AND OLDER FIRST TIME STARTERS AND ATTENTION HORSEMEN: 4-YEAR-OLD'S AND OLDER FIRST TIME STARTERS AND HORSES WHO HAVE NOT RUN FOR 365 DAYS OR MORE MUST RECORD A 5-FURLONG WORK IN FRONT OF THE VETERINARIAN AND HAVE BLOOD DRAWN BEFORE BEING ALLOWED TO ENTER INTO A RACE. THEY MUST RACE WITHIN 30 DAYS OF BEING REMOVED FROM THE VET'S LIST OR THEY WILL BE REQUIRED TO WORK AGAIN FOR THE VETERINARIAN. HORSES IN THESE SITUATIONS CAN ENTER INTO RACES "BLOOD PENDING." IF THE BLOOD DOES NOT COME BACK BY SCRATCH TIME OR THE BLOOD COMES BACK BAD, THE HORSE IS SUBJECT TO BE SCRATCHED. THIS CHANGE DOES NOT APPLY TO HORSES WHO ARE WORKING TO BE REMOVED FROM THE VET'S LIST. THOSE HORSES ARE STILL NOT ALLOWED TO FNTER "BI OOD PFNDING." ENTER "BLOOD PENDING.

ATTENTION HORSEMEN: ANY HORSE THAT HAS NOT RACED FOR 120 DAYS OR MORE WILL REQUIRE AN EXAM WITHIN 14 DAYS OF ENTRY. PLEASE CONTACT THE RECEIVING BARN TO SCHEDULE.

ATTENTION HORSEMEN: NO HORSE SHALL BE ALLOWED TO RACE MORE THAN 3 TIMES IN ANY 30-DAY PERIOD

ATTENTION HORSEMEN: CHRB RULE 1846.2 STATES THAT EVERY HORSE THAT HAS NOT HAD A RECORDED WORK OR RACE WITHIN THE PAST 90 DAYS SHALL BE SUBJECTED TO A VETERINARY EXAM BY BOTH A REGULATORY VETERINARIAN AND THE ATTENDING VETERINARIAN FOR TRAINING SOUNDNESS AND HEALTH PRIOR TO BEGINNING TRAINING. PURSUANT TO 1846.2, CHRB RULE 1846.3 REQUIRES THE TRAINER SHALL, AT LEAST 24 HOURS PRIOR TO EXAMINATION, SUBMIT TO A REGULATORY VETERINARIAN, USING A FORM PRESCRIBED BY THE BOARD, THE VETERINARY TREATMENT AND TRAINING RECORDS FOR THE PREVIOUS 60 DAYS. THESE FORMS ARE AVAILABLE FROM THE OFFICIAL VET AND ON THE CHRB WEBSITE UNDER THE VETERINARY TAB. ADDITIONALLY, THE TRAINER SHALL BE RESPONSIBLE FOR SCHEDULING A FOLLOW-UP EXAM CONDUCTED BY A REGULATORY VET AND THE ATTENDING VET 30 DAYS AFTER CONDUCTED BY A REGULATORY VET AND THE ATTENDING VET 30 DAYS AFTER THE INITIAL EXAM. THE FOLLOW-UP EXAM MUST OCCUR NO LATER THAN 45 DAYS AFTER THE INITIAL EXAM, OR ALL TRAINING MUST CEASE UNTIL AFTER THE EXAM IS PERFORMED.
